17	Section 1. Short title.	
18	This act shall be known and may be cited as the Community	
19	Services Block Grant Act.

1	Section 2. Declaration of policy.
2	The General Assembly finds and declares as follows:
3	(1) It is the intention of the General Assembly as a
4	matter of public policy to affirm the commitment of the
5	Commonwealth to ameliorating the causes and effect of poverty
6	by:
7	(i) Providing a range of services and activities
8	having a measurable and potentially major impact on the
9	causes of poverty in the community and establishing
10	grants for organizations providing services to migrant
11	and seasonal farmworkers.
12	(ii) Encouraging and supporting a holistic approach
13	designed to move low-income families and individuals
14	towards self-sufficiency.
15	(iii) Providing activities designed to assist low-
16	income participants in obtaining employment, education,
17	housing, emergency assistance, transportation and other
18	necessities.
19	(iv) Providing, on an emergency basis, for the
20	provision of such supplies and services, nutritious
21	foodstuffs and related services as may be necessary to
22	counteract conditions of starvation and malnutrition
23	among the poor.
24	(v) Coordinating and establishing linkages between
25	governmental and other social service programs to assure
26	the effective delivery of services to low-income
27	individuals.
28	(vi) Encouraging the use of entities in the private
29	sector in efforts to ameliorate poverty in the community.
30	(2) It is also the intention of the General Assembly to

- stimulate a better focusing of human and financial resources on the goal of eliminating poverty by providing for the continuity of programs which presently exist throughout this Commonwealth for this stated purpose.
- (3) By so doing, it is the intention of the General Assembly to set forth the policies which shall govern the administration of the community services block grant or subsequent funding mechanisms established for similar purposes. This block grant was created by the Omnibus Budget Reconciliation Act of 1981 and follows the provisions defined in that act.
- (4) The General Assembly also finds that the Federal funds available to finance activities under this act shall be used for the following purposes:
  - (i) To provide a range of services and activities having a measurable and potentially major impact on causes of poverty in the community or those areas of the community where poverty is a particularly acute problem.
  - (ii) To provide activities designed to assist lowincome participants, including the elderly poor:
    - (A) to secure and retain meaningful employment;
- (B) to attain an adequate education;
- 23 (C) to make better use of available income;
- 24 (D) to obtain and maintain adequate housing and
- 25 a suitable living environment;
  - (E) to obtain emergency assistance through loans or grants to meet immediate and urgent individual and family needs, including the need for health services, nutritious food, housing and employment-related

  - (2) Be a continuing and effective mechanism for securing broad community involvement in the programs assisted under this act.
  - (3) Provide effective coordination of existing community action programs with other Federal and State funds provided within the jurisdictional area targeted to the low-income population to avoid duplication of efforts within the area.
- 13 (b) Functions of agency.—In exercising its powers and
  14 carrying out its overall responsibility for a community action
  15 program, a community action agency shall have, subject to the
  16 purposes of this act, at least the following functions:
  - (1) Planning systematically for and evaluating the programs, including actions to develop information as to the problems and causes of poverty in the community; determining how much and how effectively assistance is being provided to deal with those problems and causes; and establishing priorities among projects, activities and areas as needed for the best and most efficient use of resources.
  - (2) Encouraging agencies engaged in activities related to the community action program to plan for, secure and administer assistance available under this act or from other sources on a common or cooperative basis; providing planning or technical assistance to those agencies; and generally, in cooperation with community agencies and officials, undertaking actions to improve existing efforts to attack

- poverty, such as improving day-to-day communication, closing service gaps, focusing resources on the most needy and providing additional opportunities to low-income individuals for regular employment and affordable housing or participation in the programs or activities for which those community agencies and officials are responsible.
- (3) Initiating and sponsoring projects responsive to needs of the poor which are not otherwise being met, with particular emphasis on providing central or common services that can be drawn upon by a variety of related programs; developing new approaches or new types of services that can be incorporated into other programs; and filling gaps pending the expansion or modification of those programs.
- (4) Establishing effective procedures by which the poor and area residents concerned will be enabled to influence the character of programs affecting their interests and providing technical and other support needed to enable the poor and neighborhood groups to secure on their own behalf available assistance from public and private sources.
- (5) Joining with and encouraging business, labor and 20 other private groups and organizations to undertake, together 21 with public officials and agencies, activities in support of 22 23 the community action program which will result in the additional use of private resources and capabilities, with a 24 25 view to such things as developing new employment opportunities, stimulating investment that will have a 26 measurable impact in reducing poverty among residents of 27 areas of concentrated poverty and providing methods by which 28 residents of those areas can work with private groups, firms 29 and institutions in seeking solutions to problems of common 30 20130HB0927PN2100

- alloted to establish community action agencies in those areas currently unserved; no less than 85% shall be reserved for existing community action agencies and other eligible entities as defined in section 3.
- (4) A formula basis shall be established for the distribution of funds reserved for community action agencies. The formula shall include consideration of the number of persons below the poverty level and the number of persons unemployed, as determined annually by the United States Department of Labor, and shall include a minimum funding level of community services block grant funds for existing community action agencies meeting the requirements of the Omnibus Budget Reconciliation Act of 1981 and a Statewide migrant and seasonal farmworkers' organization approved by the secretary.
- (5) A minimum funding level of only community service block grant funds shall be set at [\$150,000 or a pro rata amount if insufficient funds are available to provide the minimum amount.] an amount equal to 1.06% of the annual community service block grant allocation awarded to the Commonwealth following the distribution of administrative and discretionary funds by the department. Each community action agency shall receive no less than \$250,000 in any year. If insufficient funds are available to meet that amount, funds shall be distributed on a pro rata basis.
  - (6) As established by the formula under this section, the determination of annual funding levels shall be made by the secretary based on input from the local agencies and the Community Services Block Grant Advisory Task Force.
- 30 (a.1) Reduction or termination of funding .--20130HB0927PN2100

1	(1) Any community action agency or migrant and seasonal
2	farmworker organization which received funding in the
3	previous fiscal year under this act will not have its present
4	or future funding terminated under this act or reduced below
5	the proportional share of funding it received in the previous
6	fiscal year unless, after notice and opportunity for hearing
7	on the record, the Commonwealth determines that cause existed
