## Pennsylvania Economic Development Financing Authority November 15, 2023

## ASSISTANT DIRECTOR RESOLUTION

Mr. Petrasic stated, "Since I have moved into the Executive Director position, Brian has now been promoted to fill my old position. We wanted to get him appointed Assistant Director as I had been previously. This is practice in case I would become incapacitated or otherwise unable to perform my duties. So we would recommend approval of that."

No words rang truer than his. I can't imagine what you guys on staff must go through. To execute on these deals, deal with these companies, have a local industrial development authority bringing them to you. Dealing with egos associated with investment bankers, bond counsels, attorneys,

executives, CFOs, and corporate treasurers. I would have gone off years ago if I was in your shoes. All we see every month is a bulletproof package that we have the privilege to vote on. It is to Craig, Brian, Melanie, and Gail who we see and all the other staffers who we don't see that make the magic work. I'm voting yes. But I also want to acknowledge all the others behind the scenes who bust their tails that we don't see every single day, to do good things for this state."

Mr. Brubaker stated, "That was fantastic, Nick. I enjoyed that very much. It was factually accurate and very well stated. Great job."

Mr. Haden stated, "Thank you."

It was moved by Mr. Brubaker and seconded by Mr. Haden that the Board approve the appointment of Brian Deamer as Assistant Director. The motion carried.

Ms. Book stated, "We very much appreciate it. Brian, that was a ringing endorsement of you, but also the staff in general."
