



FILM PRODUCTION TAX CREDIT QUALIFIED PRODUCTION FACILITY AFFIDAVIT

APPENDIX M

A film production company (taxpayer) can obtain an additional tax credit in the amount of 5% of Qualified Film Production Expenses incurred by the film production company if the film production company films a feature film, television film or television series, which is intended as programming for a national audience and films in a "Qualified Production Facility" which meets minimum stage filming requirements. This form will be used by the Department of Community & Economic Development to determine if a facility qualifies as a "Qualified Production Facility."

"Qualified Production Facility" means a film production facility within the commonwealth that contains at least one sound stage with a column-free, unobstructed floor space and meets either of the following:

1. Has invested a minimum of \$10,000,000 in the facility in land or a structure purchased; a ground-up, purpose-built new construction; or renovation of an existing improvement. (must provide proof of \$10,000,000. investment)
2. Meets at least three of the following criteria (provide proof of selected criteria below):
