ORDINANCE NO. 1173

AN ORDINANCE OF THE BOROUGH OF BRADDOCK, ALLEGHENY COUNTY, PENNSYLVANIA, APPROVING CERTAIN AMENDMENTS TO THE BOROUGH OF BRADDOCK'S ACT 47 REVISED RECOVERY PLAN, AS AMENDED, AS PREPARED AND PROPOSED BY THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT THROUGH THE RECOVERY PLAN COORDINATOR, RESOURCE DEVELOPMENT & MANAGEMENT, INC.

BE IT ORDAINED AND ENACTED BY THE BOROUGH OF BRADDOCK, ALLEGHENY COUNTY, PENNSYLVANIA AND IT IS HEREBY ORDAINED AND ENACTED BY AUTHORITY OF THE SAME AS FOLLOWS:

Section 1. Findings and Purpose. The Borough of Braddock (Borough) is a financially distressed municipality subject to the provisions of the Municipal Financial Recovery Act, 53 P.S. § 11701.101 *et seq.* (the "Act"). In accordance with the provisions of said Act, a financial recovery plan was adopted by the Borough on November 21, 1988, as amended in 1989, 1990 and 2001. Due to the passage of time and changes in financial conditions, the Borough's Act 47 coordinators at Resource Development and Management, Inc. proposed a further Recovery Plan Amendment which contains financial management recommendations that more accurately reflect and address the Borough's current financial condition and concerns. Borough Council has determined that adopting the proposed Recovery Plan Amendment is appropriate at this time as part of the Borough's efforts to maintain a balanced budget while providing the highest level of public services possible under the circumstances.

Section 2. Plan Amendment. The Borough hereby amends the Borough's Revised Recovery Plan, adopted on November 21, 1988 by Ordinance No. 8-88, as amended on December 12, 1989, August 25, 1990 and June 12, 2001 by Ordinance Nos. 6-89, 1-90 and 1093

respectively, in accordance with the Evaluation of Act 47 Status and Recovery Plan Amendments prepared and proposed by the Pennsylvania Department of Community and Economic Development through the Borough's Recovery Plan Coordinator, Resource Development & Management, Inc. Said Evaluation and Recovery Plan Amendments are attached hereto as Attachment "A" and incorporated by reference as though fully set forth herein.

Section 3. Incorporation. All other provisions of the Revised Recovery Plan, as amended, shall continue in full force and effect as originally proposed by the Borough's then Coordinator and adopted by the Borough.

Section 4. Authorization. The Borough Council hereby authorizes the enactment of all ordinances and amendments to ordinances necessary to the implementation of the Recovery Plan Amendments to the Revised Recovery Plan, as amended, as required by Section 249 of the Financially Distressed Municipalities Act (Act 47 of 1987).

Section 5. Repealer. All ordinances or parts of ordinances inconsistent herewith are repealed insofar as they affect this ordinance.
