The typical family experiencing homelessness is a single mother with two young children, and in PA, 3% of children are being raised by their grandparents which is higher than the 2% national average. More than 50% of U.S. homeless families with children are African American, and 65% of the families in BHA's Transitions program are headed by African American women. Additionally, according to the US Interagency Council on Homeless, in the 2017 Point-In-Time survey, women represented 77.6% of the adults counted as experiencing homelessness in families with children. In addition, 93% of mothers experiencing homelessness have experienced at least one trauma in their lives. Trauma is linked to higher rates of mental health disorders and substance abuse. These disorders compromise a mother's ability to form safe and trusting relationships, maintain employment, and parent effectively. BHA will provide bridge housing and supportive services to prevent homelessness for the families served in the Transitions program, who are single mothers and grandmothers with children experiencing homelessness. Participants in the Transitions program work closely with their BHA Family Advocate to remove housing barriers and learn the skills needed to maintain their housing. Participants attend weekly goal planning meetings and a group program where they learn "life skills" including budgeting and housing preparation. Needs assessments and trauma assessments are conducted with all participants, and connections are made with community resources to help address issues that may be hindering the participant's success. Measurable outcomes for the Transitions program include a) obtaining/maintaining housing; b) achieving a reliable income to sustain their permanent housing; c) connecting with community resources and supports; and d) successfully completing Life Skills classes offered.</p>	M&T Bank, UPMC
202105256767	Paladin Development - Harrisburg, Dauphin County	NAP	\$110,000	<p>Bethel Village is a 49-unit, 100% affordable community for seniors to be built on the 1000 block of N. 6th Street near the State Capitol. Community space in the building will accommodate supportive services for tenants and neighborhood residents. The site is a stop on a tour that profiles the Historic Bethel AME Church's role during the Civil War and is adjacent to the former Jackson Hotel, which hosted prominent African Americans during the Jim Crow era. Despite its significance to the black community, the block has seen disinvestment and abandonment. The building of Bethel Village and its community space responds to the need for affordable housing and on-site services for seniors, the homeless and those with special needs in a COVID safe setting, and promotes social justice, as its owners include minority partners and it will help restore a historic black neighborhood to economic health. In 2014, CAY partnered with Wells Fargo and Ophelia Chambliss in developing the Sonny Simpson Community Play Zone, a blighted property previously located at 524 S. Duke Street, resulting in the improvement of our southeast neighborhood. This project will help mitigate from the pandemic through the redevelopment and modification of the play zone while offering a safe, clean, and open play space for our city's youth as well as those who attend our Early Learning Center and Rising Stars Youth Program. This project expands PIRC's citizenship services in both geography and scope to LPRs in Cumberland and York Counties who face significant barriers to naturalizing. This project will reach 30 LPRs through outreach and education; screen 15 LPRs for eligibility for naturalization; and assist 40 individuals with preparation of any supplementary applications for which they are eligible. Additionally, this project will support 10 LPRs with free legal assistance with the N-400 application packets. Project services will be provided first in Hanover and Carlisle then expand into other parts of Cumberland and York Counties, as possible. We seek to renovate a blighted, single brick house located behind our main building. This was a two-unit rental property that we closed several years ago. The exterior of the building is in disrepair; but the engineering report says the building is structurally sound. The interior requires renovations to move from two apartments into office and meeting space to be the new home of our Community Education department and Racial and Gender equity program. This will give the CE department the ADA-compliant space to hold community meeting/trainings that their current location does not offer. We will repurpose their current location to the new complex trauma transitional housing for victims of domestic violence and human trafficking who are facing complex trauma. The prior community education space will almost double the current capacity so we can serve more clients in our community. YWCA York seeks to renovate a blighted, unused building to be the new home for Community Education. This center is intended to address the needs of poverty, unemployment and underemployment that exists within the Hispanic community. We will replicate the model of Lancaster SACA's Tec Centro to provide these services. Since 2000, the Hispanic community has increased by 155%. Over 30% of the population of the City of York is Hispanic, compared to 7% county wide. The poverty rate of Hispanics was 32.1% in York County and 47% in York City compared to an overall poverty rate of 16% in York County. The graduation rate of Hispanics in York City School district is about 54% compared to 96% for all students at Central York School District. The SAMRC Tec Centro plans to address these inequalities by providing Hispanic and Latinx individuals with the opportunity to (1) improve their language skills (2) improve their academic performance and (3) acquire marketable job skills. Forty-four percent of people living below the poverty line use public libraries for internet access. In 2019, visitors to Dauphin County Library System's eight locations spent 4.8 million minutes on public computers. The heaviest usage occurred at a branch in the lowest-income neighborhood, McCormick Riverfront Library. People used internet to complete school assignments, apply for jobs, and secure government services. The pandemic caused massive disruption to this vital service. Even as The Library reopens, internet access is affected; public-use computers are clustered and not conducive to social distancing. Currently, 65% of computers at McCormick are out of use due to social distance requirements. Reconfiguring the computer lab will allow for social distancing, full use of all computers, plus add data and charging ports for personal devices and loaned laptops. The reconfiguration will include designing a completely new system to separate the current centralized data hub into individual, socially distanced stations, installing new cabling and infrastructure to support the stations, and creating an IT closet to house the infrastructure. Land has been purchased for the purpose of building a "food hub" that will bring the café and food pantry into one, new location. As an outgrowth of the pandemic, the demand for housing has soared and the Lewistown facility of Clayton is attempting to catch up with a current backlog of 500 units. 25 new employees are expected to join the current 217 Team members to increase production one additional unit per day through the initiation of this project. During the unprecedented COVID-19 pandemic, the Food Bank reallocated many of our resources and adjusted our direct assistance programs in order to meet the greatly increased need, as well as to maintain social distancing and sanitation guidelines. We began distributing emergency food boxes at our Food Hub location in the form of a drive-thru. These mass distributions allow individuals to remain in their vehicles while Food Bank staff and volunteers place pre-packaged boxes of food, as well as fresh and frozen items, in their car to limit social interaction. Additionally, we hosted several pop-up distributions across the county in areas designated as being of high need and having low access to food assistance resources. These adjusted methods have allowed us to meet the vast need during these difficult times, serving hundreds of families at each distribution. Funding from the Charitable Food Program will allow the York County Food Bank to streamline its processes to improve its efficiency, expand its capacity, and increase emphasis on the provision of fresh, healthy food. Due to the economic consequences of the pandemic, Feeding America (the nationwide hunger fighting organization) estimates that this number has grown to as much as 16.2% in some of the counties we serve. The signs of recovery in our communities are encouraging; yet we know from past economic downturns that it takes time for levels of food insecurity to decrease in alignment with improved economic indicators. As CPF shifts from an urgent crisis response, to a sustained recovery we know a significant number of our neighbors will still need a helping hand for months, even years to come. In 2021-2022 with support from the Neighborhood Assistance Program, Central Pennsylvania Food Bank will feed local families recovering from the pandemic. Together with our partners (food and financial donors, 1000+ partner agencies, volunteers, and more), Central Pennsylvania Food Bank will source and distribute food to our food insecure neighbors. In the next year, we anticipate providing more than 70 million pounds of food to more than 450,000 individuals experiencing food insecurity. As our communities start to recover from the COVID-19 pandemic, we are committed to continuing to provide food for our neighbors who need it. We anticipate serving in a heightened capacity for at least another two years. We are committed to doing so with an acute focus on equity, recognizing that our neighbors of color and rural neighbors have been most impacted by the economic consequences of the pandemic.
