The chart below is intended as a helpful guide, and not an exact list of what are considered Qualified Expenditures. Qualified Expenditures are for pre-production, production and post-production - not for development, marketing, publicity or distribution. The following list assumes where "yes" is designated that the service is performed or property is used in the state of Pennsylvania.

**Q & A - CLARIFICATIONS****Q. Is there a limit on salaries and wages?**

A. All salaries and wages earned in PA if such amounts are subject to PA taxation are eligible expenses; however, there is a cap of \$15 million in aggregate above the line payment for salary of a principal actor, whether paid directly to or through a loan-out company. Salaries and wages does not include items such as reimbursement for expenses or fringe benefits.

**Q. What is the definition of PA Based?**

A. Applicants need to register to do business in PA by going to the Department of State website and completing a certificate of authority and docketing statement. Refer to Section VII of the Film Tax Credit Guidelines.

**Q. If a per diem is paid based on federally approved rates or less than those rates instead of the production reimbursing for meals, etc., does the per diem qualify?**

A. Yes the per diem qualifies; however, receipts must be retained in the event of an audit.

**Q. If a "living allowance" is paid instead of the production company paying the hotel bills, etc., does this qualify?**

A. A living allowance qualifies and must be reported as taxable income to the loan-out company or the individual.

**Q. Will loan-out companies be required to have a physical office in PA?**

A. Loan-out companies need to be registered to do business PA; however, they do not need to have a physical office in PA.

**Q. If payments for kit rentals and equipment rentals are made to a PA vendor or individual, but they do not collect PA sales and use tax, does the expense qualify?**

A. No. The PA vendor or individual that holds a valid sales use license must collect sales tax on taxable items or the individual and/or company will need to pay the use tax in order to qualify as an eligible expense.

**Q. Are rentals from people that are not in the business of renting eligible expenses? For instance, an individual owns a classic car that the production company wants to use for a day. The individual does not ever rent his car out, but agrees to for the film.**

A. This is not an eligible expense since the individual is not in the business of renting vehicles.

**Q. Does all forms of travel qualify?**

A. Travel expenses for actors and crew are eligible expenses to and from and within PA.

**Q. Do costs related to companies such as spouses, children, nannies, trainers, assistants, etc., qualify?**

A. No; however, if a trainer is being paid through a loan-out company that qualifies as an eligible expense.

**Q. Do payments made to a non US citizen hired as talent and paid by a payroll company eligible expenses?**

A. Only if local tax is paid according to the rules for non US citizens working in PA.

**Q. Are wages considered subject to taxation to PA if paid to a resident of a reciprocal state?**

A. Yes, if there is a PA state tax withheld. Reciprocal states to PA include: Indiana, Maryland, New Jersey, Ohio, Virginia and West Virginia.

**Q. Unit publicity expenses can qualify according to the chart of account. Are these not considered marketing and advertising expenses?**

A. Yes. Unit publicity and Still photographer are consider part of the crew and will be on the ground working.

**Q. The film production company rents or purchases products, items, goods, services or supplies from an out-of-state vendor, do these expenses qualify?**

A. These rentals or purchases are not qualified Pennsylvania production expenditures.

For an expense to be considered a qualified Pennsylvania production expenditure and count toward qualified production expense calculation, the rental or purchase of products, items, goods, services or supplies must be from a Pennsylvania-based company which is defined in the guidelines as:

1. registered to do business in Pennsylvania
2. regularly engaged in the business that provides the products, items, goods, services or supplies.
3. maintains inventory, products, items, goods, services and supplies in Pennsylvania.
4. currently maintains and has maintained operations throughout the twelve month period preceding the commencement of the production; inventory, products, items, goods, services and supplies in Pennsylvania.

**Q: What happens if a Pennsylvania-based company does not have a 3-D camera, what do we do?**

A: If a film production company needs an item for production and it is not available from a Pennsylvania-based company listed below are the following options:

1. Does not count towards the qualified Pennsylvania production expenditures.
2. Obtain three (3) quotes from vendors that are in this business of providing the type of item in question which indicate that the vendor does not have the item. The quote should include: the name of the vendor and contact information including name of individual contacted, the date and time. This information must be supplied along with receipts for the expenditure to be considered a qualified Pennsylvania production expenditure.

**BOX RENTALS****Q: Must the film production company renting the box be charged sales tax in order for the box rental to qualify as a qualified Pennsylvania production expenditure for the incentive?****Q: Can the film production company pay a use tax on the box rental if no sales tax is charged and count towards a qualified Pennsylvania production expenditure?**

The film production company hires the make-up artist. The artist is paid more if he/she supplies his/her own make-up. The make-up artist is using the make-up to perform his/her nontaxable service and there is no transfer of make-up to the film production company. In this example the artist is required to pay sales or use tax on his/her purchase of the make-up used in performing the nontaxable service. The artist would build that cost of the sales tax paid into the price he/she is paid. In this example there is no use tax to be claimed by the film production company, it is built into the amount paid to the artist.

If the artist bills the film production company for the make-up used separately from the artist's services then the artist may purchase the make-up tax free and should bill the film production company sales tax on the sale of the make-up. If this is the case and the artist does not charge sale tax, then the film production company may accrue and pay use tax directly to Pennsylvania Department of Revenue.

**TRAVEL EXPENSES**

**Example: Flight** – Fly from California to New York and then onto Pennsylvania. The only portion of the flight expense that will qualify as qualified Pennsylvania production expenditures is the flight from New York to Pennsylvania.

**Example: Train** – Take a train from North Carolina to Pennsylvania with an overnight stop in Virginia. Get back on the train in Virginia and travel to Pennsylvania. The only portion of the expenses that counts toward qualified Pennsylvania production expenditures is the train ride from Virginia to Pennsylvania.

**ONLINE PURCHASE****Q: Can an online purchase be considered a qualified Pennsylvania production expenditure?**

A: Yes, an online purchase can be considered a qualified Pennsylvania production expenditure, if the vendor charges Pennsylvania sales tax or the production pays a Pennsylvania use tax on the online purchase.

**Form 1099****Q: Do 1099 non-employee payments to non-residents qualify as “compensation paid to individual on which the tax imposed by Article III will be paid or accrued”?**

A: Yes. If the compensation was paid they are able to show the PA tax was remitted.
