Prior to the regular Board meeting, Dan Betancourt, President & CEO and Glenda Machia, Vice President, Development, with Community First Fund, a community building grantee who was awarded \$350,000 from Impact Harrisburg provided a handout and Power Point presentation to the Board regarding their revolving loan program. The Board was interested in learning more about their loan process and who was eligible to receive a loan.

Community First Fund will use their award money to create and operate the Harrisburg Opportunity Loan Fund, a permanent revolving loan fund to support business and commercial development, with a focus on Midtown and Allison Hill neighborhoods. The project will help tear down barriers that persons of color, especially minorities and women, face in accessing business loans. Community First was recently awarded a grant from Wells Fargo that will support the hiring of an individual to administer the grant. Their funds will be matched by \$1.4M in other funds to create a \$1.75M loan fund for the program. The mission of Community First Fund is to create economic opportunity for low income communities and individuals, including people of color and women. The presentation was well received and satisfied the Board's questions and concerns.

## 2. Treasurer's Report

The first Tuesday in July falls on a holiday, therefore, the Board will meet on Thursday, July  $6^{\rm th}$ .
