# **COMMUNITY SERVICES BLOCK GRANT**

COMBATTING THE CAUSES OF POVERTY

The mission of federally-funded Community Services Block Grant (CSBG) helps low-income families and individuals transition to selfsufficiency through providing a holistic suite of services addressing the causes and conditions of poverty.

The CSBG funds are distributed to certified Community Action
Agencies (CAAs) or local
government units covering every
Pennsylvania county according to an
entitlement formula. These
organizations are responsible for
creating greater community
engagement and partnerships in
order to ameliorate the barriers that
prevent individuals from achieving
self-sufficiency and life goals.

As a local catalyst for combatting poverty, each CAA sets priorities based on three-year Community Needs Assessments, and deploys resources following the Results-Oriented Management & Accountability (ROMA) model. The unique board structure of CAAs promote community-building by including equal representation of individuals experiencing poverty, local elected officials, and community advocates and service organizations.





#### WHO'S ELIGIBLE?

Pennsylvania residents with an income 125% or below the Federal Poverty Guidelines set by the Federal Office of Management and Budget are eligible to receive direct services from agencies funded through the Community Services Block Grant (CSBG).

#### **SERVICES**

CSBG funding supports services designed to address the causes of poverty in local communities through programs and services promoting economic stability and security, healthy communities, and active opportunity-building and community engagement.

Typical uses of the CSBG funding include, but are not limited to:

- Case Management
- Job Training & Workforce Supports
- Food and Nutrition
- Community Engagement
- Housing
- Drug and Alcohol Supportive Services
- Economic Development
